Be it resolved that the Council of the Township of Perry does hereby now adjourn from this Regular Meeting at 7:12 p.m. to commence a 'Public Meeting' for the purpose of hearing comments from members of the public with regard to a proposed Zoning By-law Amendment for lands legally described as Part of Lot 25, Concession 1, designated as Part 1 on Plan 42R-20629 and the remainder of Part 7 on Plan 42R-10819, in the Township of Perry located at 482 Fish Lake Road/Savage Settlement Road (Beckerton).

Mayor Hofstetter as the Chair advised that this is a Public Meeting to hear public comments and answer questions regarding the proposed Zoning By-law Amendment for lands legally described as Part of Lot 25, Concession 1, designated as Part 1 on Plan 42R-20629 and the remainder of Part 7 on Plan 42R-10819, in the Township of Perry located at 482 Fish Lake Road. The purpose of the proposed by-law is to rezone the retained lands located on Savage

Settlement Road described as the remainder of Part 7 on Plan 42R-10819 from the Shoreline Residential Backlot (SBR) Zone and Rural (RU) Zone to a Rural Residential (RR) Zone and the severed portion located at 482 Fish Lake Road from the Shoreline Residential Backlot (SBR) Zone and Shoreline Residential (SR) Zone to a Shoreline Residential Exception Twelve (SR-12) Zone to recognize a reduced lot frontage of 87 m. This application is a Condition of Consent Application B-008/16.

He outlined how the Public Meeting would be conducted. He stated that the Clerk would advise as to when, how and to whom notice of the public meeting was circulated and confirm proper notice was given.

He noted that the public meeting is not a public debate on the matter. The public will be afforded the opportunity to provide their comments or questions. He outlined that persons in favour of the application would go first. Those in opposition to the application would follow. He also advised that people providing comments or questions are asked to present them through him as the Chair.

He then noted that Council will have the opportunity to question the applicants, planning consultants or agents. He also advised that Council will consider the Zoning By-law Amendment at a future Regular Meeting of Council. He stated that all persons addressing Council must state their full name, full mailing address and postal code and must direct their comments through the Chair.

Mayor Hofstetter then requested that the Clerk advise as to how and to whom notice of the public meeting was circulate.

The Clerk advised that Notice of this Public Meeting was given by posting the application on the Township's website, www.townshipofperry.ca on November 3 2016; forwarding it to all persons and public bodies as prescribed under the *Ontario Planning Act* Regulation, including owners within 600 feet of the applicant's property; and to those requested. Notice was also posted at the Municipal Office, and to those requested.

Mayor Hofstetter then declared this to be a public meeting to deal with the proposed Zoning By-law amendment.

Mayor Hofstetter asked the applicant and/or their representatives to provide their comments on the proposal. No comments came forward.

Mayor Hofstetter then invited members of the public to speak on the proposed Zoning By-law Amendment. No comments came forward from the public.

Mayor Hofstetter asked the Clerk what letters have been received with respect to the application.

The Clerk advised that as of 4:30 p.m. today, the Municipality had received one comment from MTO with no concerns in relation to the proposed zoning by-law amendment.

Mayor Hofstetter asked if there were any questions or comments from Council on the proposed Zoning By-Law Amendment. No questions or comments from Council came forward at this time.

Mayor Hofstetter advised that those wishing to receive further notice of the Notice of Decision of the Zoning By-law must make a written request as per previous instructions. He advised that Council will be considering the by-law at a future Regular Meeting of Council and outlined that once Council makes a decision on the by-law, there is a 20 day appeal period from the date of decision of the by-law during which time any person may appeal the decision of Council to the Ontario Municipal Board.

Having received no further questions or comments from the Public or Council members, Mayor Hofstetter declared this public meeting to be concluded and presented the following resolution:
