This is five on five co-ed ball hockey for ages 6 and up including adults. Players will play on the smooth asphalt surface at the Novar Community Park, located behind the Novar Fire Hall on McCrandle Street, just off Boundary Road. Games will be held on Wednesday and Saturday evenings.

- Registration will be held on Saturday, April 15, 2017 between 4 -7 pm at the Novar rink.
• The first game is scheduled for Wednesday May 3, 2017 at 7 pm. The season will run until the end of June.

Organized ball hockey is NON CONTACT.

MANDATORY EQUIPMENT FOR PLAYERS IS A PLASTIC BLADE HOCKEY STICK, RUNNING SHOES, A HELMET AND GLOVES OF ANY TYPE. Recommended equipment includes a face shield, light duty shin and elbow pads, and an athletic supporter with cup.

Registration forms must be signed by a parent or guardian and the Indemnification on the reverse must also be filled out if the player is under the age of 18. All players must complete the Perry Township Waiver of Liability and Assumption of Risk form on the reverse. There is a registration fee of \$15.00. Cheques should be made payable to the Township of Perry.
