**TOWNSHIP OF PERRY FARMERS' MARKET**  
**2017 MARKET SEASON REGULATIONS**

- 1) The Township of Perry Farmers' Market will be open to the public at 10:00 a.m. and closed at 4:00 p.m. every Friday morning from June 30th to September 1st or longer depending on weather and demand.
- 2) Vendors may arrive for set up no earlier than 9:00 a.m. and clean-up will end no later than 4:30pm.
- 3) All vendor spaces will be in the large parking lot of the Township of Perry Municipal Office or in the gazebo area with no vehicles parked on grass.
- 4) No vendors may begin selling, except to other vendors, prior to 9:00 am.
- 5) Vendors are required to provide their own tables (mandatory) and tents (optional). For safety, all tents must be properly weighted or secured to the ground.
- 6) Vendors are expected to keep their immediate site clean and orderly.
- 7) All garbage must be kept to an absolute minimum and removed by each vendor at move out.
- 8) If a vendor cannot attend a particular market day, please notify the Township immediately.
- 9) Vendors should be mindful of keeping the surrounding area in good condition and notify the Township of any damages.
- 10) All vendors will show respect to fellow vendors, customers and market volunteers.
- 11) Applicable products are subject to approval by the North Bay Parry Sound District Health Unit.
- 12) All rules and regulations are to be enforced by the Township of Perry. Regulations are subject to change.
- 13) The Township of Perry reserves the right to cancel the privileges of any vendor at any time that has wilfully violated the regulations of the Market. No refunds will be given.
- 14) Please note that smoking under the Farmers's Market Gazebo is prohibited during operational market hours. The Township prohibits smoking within 20 metres of any municipally-owned building.
- 15) The Township of Perry Farmers' Market By-law shall further govern the Farmers' Market.

You further agree to accept sole liability for the consequences, legal or otherwise, of any injury or loss to persons, whether vendors or market visitors; or any injury, damage, or loss to the property of vendors or market visitors; that results from your failure to properly guard and secure your tent, or which results from your failure to guard and secure any other item constituting your setup or display or possessions; and you, therefore, indemnify and hold harmless from all claims the Perry Farmers' Market and the Township of Perry and its employees.
