Quotation Submission Form

For 2018, 2019, 2020

Sand for cover material sand free from debris and organic material to be delivered and stockpiled at the Rain Lake Landfill Site, Kearney Ontario. The successful contractor will provide two separate deliveries, ½ of the requested total material preferably prior to Half load restrictions and the second ½ during the month of August. Timing and exact location of delivery to be co-ordinated with the Landfill operator who's contact information will be provided to the successful contractor.

Quantity of material: 955 cubic metres. (using Toarc's conversion rate of 1.78tonnes/m3)
Tickets may be used for reference.

Payment: Upon confirmation of delivery from the Landfill operator and submission of invoice payment will be made for 85% of the invoice within 30 days.

Holdback: A holdback in the amount of ten (15%) per cent of the total Cost shall be enforced for a period of thirty (30) days after completion date of the work. If the contractor sub-contracts any portion of the required quantity or the delivery of materials, proof of payment in full to the sub-contractor, must be presented to release the holdback and a cheque issued to the contractor for the holdback.

Insurance: The successful contractor is to deliver a certified copy of the Firm's Public Liability and Property Damage Insurance Policy for the works, within ten (10) calendar days of receiving the Acceptance Notice. Coverage shall be at least two-million (\$2,000,000) dollars per accident in the name of the Kearney Perry Joint Waste Management Board.
Failure to provide such proof shall result in cancellation of the Contract.

WSIB: The successful contractor shall submit, within ten (10) calendar days of receiving acceptance notice, proof of WSIB Coverage.

The Kearney Perry Joint Waste Management Board reserves the right to reject any or all quotations and the lowest or the highest, as the case may be, will not necessarily be accepted. The Township reserves the right to cancel or delete any portion of the work outlined and the Contractor agrees to such cancellation or deletion without claim whatsoever because of such cancellation or deletion.
