**INSTRUCTION FOR COMPLETING
ENTRANCE APPROVAL APPLICATIONS**

1 NAME, ADDRESS, AND TELEPHONE NUMBERS

Print your name, present mailing address and telephone number.

2 ROAD NAME

Print the local road name at the processed entranceway with the Lots, Concession number, and Plan number if any.

3 SKETCH

Please draw a sketch in the area provided showing the location of the processed entranceway to assist the Roads Superintendent in locating the site. Stake and tag the desired location with the tag provided.

Being Regulations governing the size area and mode of construction of entrance ways, culverts, and bridges over drains, ditches, and watercourses on Township road allowances, and fees for permits and other charges pursuant to the Township of Perry.

1 The fee for an Entranceway Permit is \$250.00 and will be in effect for six months. If a second Permit is required, the fee is \$250.00 and is valid for a six month period.

2 A security deposit in the sum of \$ 350.00 is required, which will be returned upon final approval by the Roads Superintendent.

3 The minimum size of culverts -fifteen inches (15") or thirty-eight centimetres (38 cm) and the length is twenty-eight feet (28') or eight and on-half metres (8.5m).

4 DEPOSIT

Entrance Approval applications require a payment in the amount of \$600.00 made payable to The Township of Perry (Fee- \$250.00, Security-\$350.00)

Upon completion of the application form, return it to the Township of Perry Office. The payment must accompany the application.

The location approval will require from one to two weeks after which you will receive a notification that you may proceed to install the entrance. Work on the entrance must not begin unless you have received approval.

5 **FINAL APPROVAL**

If the work has been properly completed your Deposit (\$350.00) will be returned to you (Please allow two weeks for Final Approval)

NOTE: The Property Owner shall be responsible for culvert replacement should the culvert be damaged during construction associated with an active Building Permit.

6 **CIVIC ADDRESS**

A civic address post and number will be assigned once your entranceway has been completed (Approved Final Inspection) and a building permit issued. The civic application form and the fee of \$60.00 must be submitted separate from the entrance approval application. A civic address number will be assigned once your entrance way has been completed (final approval) AND a building permit has been issued for the dwelling (cottage or home).
