NOTICE OF THIRD PARTY ADVERTISING

This notice is for anyone proposing to be a third party advertiser or any candidate accepting third party advertising for the 2018 municipal election on October 22, 2018 within the Township of Perry.

New this year are rules for third party advertising. A third party advertiser is any individual, corporation or trade union that causes an election campaign advertisement to appear. Third party advertisers are required to register with the Clerk in every municipality where they want to advertise. Registrations of third party advertisers will be accepted between Tuesday, May 1, 2018 and Friday, October 19, 2018 by appointment only.

Third party advertisers are not entitled to a copy of the voter's list.

Until the Clerk certifies the registration, a third party advertiser may not spend money on their campaign, accept contributions or begin advertising. The registration form will be available from the Clerk at 1695 Emsdale Road, Emsdale, Ontario or email beth.morton@townshipofperry.ca to make an appointment.


