

## THE CORPORATION OF THE TOWNSHIP OF PERRY

### BY-LAW No. 2013 - 45

Being a By-law to Amend By-law 2006-01 being a By-law to regulate the keeping and controlling of dogs, dog kennels and certain other respects within the Township of Perry

**WHEREAS** the *Municipal Act, R.S.O., 2001* Section 103 authorizes the Council of a municipality to pass by-laws regulating or prohibiting with respect to the being at large or trespassing of and control of dogs in the municipality;


**AND WHEREAS** The Council of the Corporation of the Township of Perry deems it advisable to enact such a By-law.

### **NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF PERRY ENACTS AS FOLLOWS:**

1. That Schedule 'A' to By-law #2006-01 is hereby removed and replaced with Schedule 'A', attached hereto.
2. That 2. (a) "Every owner of a dog is required to purchase a dog tag, which shall be valid for the lifetime of the individual dog for which the tag was originally obtained" shall be removed and replaced with: "2. (a) Every owner of a dog is required to purchase a dog tag, annually on or before the 15<sup>th</sup> of March of each calendar year and shall expire on the 14<sup>th</sup> of March of the following year. Lifetime tags will continue to be valid for the lifetime of the individual dog for which the tag was originally obtained."
3. That the following clause be included after 2. (b) "2. (c) If the dog that the tag was originally purchased for becomes deceased or no longer resides with the owner, the owner shall notify the Township, so that the Township's records may be updated."
4. That the following clause be included after 14. (b) "14. (c) Persistently bark, whine, whimper or create any noise that is likely to disturb any inhabitants of the Township."
5. That the following clauses be included after 16. (b) "16. (c) Notwithstanding any of the provisions of this By-law, any person who has been served with a Violation Notice alleging the commission of an offence contrary to the provisions of this By-law may, where a Violation Notice is issued specifying from the date of issue of the Notice of Violation, excluding Sundays and holidays to a location specified on the Violation Notice, and if the said amount is paid, no further proceedings shall be taken under this By-law in respect of the offences alleged in the Violation Notice; 16. (d) Set Fines related to this By-law shall be found in Schedule 'B' of By-law #2006-01, which shall be attached and form part of this By-law."
6. That in all other respects, the provisions of By-law 2006-01 and its amendments shall apply.


7. This By-law shall take effect upon the date of passage.



Various Fees Related to By-law #2006-01, as amended

License Fees

Dog tag fee	\$10.00
Replacement Tag	\$5.00
Kennel License	\$150.00
Guide or Service Dogs	FREE

Impounded Dog Redemption Fees:

1. **ALL** boarding, maintenance, adoption and other fees required by the Animal Shelter for the impounded dog.
2. **ALL** veterinarian fees and others service performed on behalf of the impounded dog, by the Township.

**NOTE:** All impounded dog redemption fees must be paid prior to the dog's release from the Animal Shelter.

**PART 1 PROVINCIAL OFFENCES ACT**

By-law 2006-01, as amended: A By-law to Regulate Dogs

<b>Short Form Wording</b>	<b>Provision creating or defining offence</b>	<b>Set Fine</b>
1. Failure to purchase dog tag	2 (a)	\$50.00
2. Failure to affix dog tag	5 (a)	\$50.00
3. Owner permit a dog to wear a dog tag other than the one issued for the dog	5 (b)	\$50.00
4. Failure to obtain a kennel license	6 (a)	\$200.00
5. Owner permit more than three dogs	10 (a)	\$50.00
6. Owner permit dog to run at large	11 (a)	\$50.00
7. Failure to leash dog	12 (a)	\$50.00
8. Failure to clean up dog excrement	13 (a)	\$50.00
9. Owner permit persistent barking	14 (c)	\$50.00

NOTE: The penalty provision for the offences indicated above is Section 16 (a) of By-law 2006-01, as amended, a certified copy of which has been filed.
