<u>Item 7.4 Village of Burk's Falls – AHHC Long Term Proposal for Contribution</u> <u>Agreement {Discussion}</u>

Council discussed the proposed contribution agreement for AHHC, as presented from the Village of Burk's Falls. The proposed contribution agreement would take effect in 2024 forward.

Mayor Hofstetter led the discussion by noting that based on the material presented, he would prefer to keep the municipal contribution to AHHC as status quo, where the Village of Burk's Falls invoices applicable municipalities their portion based on the previous year deficit. The remainder of Council supported Mayor Hofstetter's position on this and directed staff to prepare a resolution supporting Option #1 within the proposed Contribution Agreement to the next regular Council meeting on May $3^{\rm rd}$, 2023.
