# <u>Item 4.1. DELEGATION - Haily Bender, Resident of Perry Township, RE: Concerns Surrounding Scotia Road</u>

Haily Bender thanked Council for hearing her delegation regarding some safety and traffic concerns on Scotia Road, and highlighted the following:

- Hoping to open the dialogue to make the road safer; personally, had many close calls and is aware of one major accident since it became the detour for the Highway 592;
- Suggestions to the Township to make some adjustments before the summer season where a serious injury or accident is more than likely to occur
  - The alignment of the road, since it's been repaved, is poor with no shoulders. Additionally, as it is paved people now speed regardless of the fact that the speed limit was reduced to 40km/hr.;
  - Painting a centre line on the road, instead of the misleading paving indicators;
  - Keep right signage over the blind hill;
  - Speed limit indicator.

#### Item 9.1. Scotia Road - Discussion and Direction

Mayor Hofstetter thanked Ms. Bender for her delegation and information. Mayor Hofstetter requested that Item 9.1 "Scotia Road" on the Agenda be discussed following the delegation and Council agreed.

Mayor Hofstetter advised:

- The Township is aware of the growing concern on Scotia Road and unfortunately with the MTO's timelines for replacing the Ragged Creek Bridge along Highway 592 being routinely extended, it has not helped matters;
- There was no discussion between MTO and the Township when the detour was established. MTO simply erected the signs – poor communication all around between the MTO and contractors;
- The Township did hire an engineer to conduct an inspection of the road and provide suggestions to ensure it was more safe for vehicle traffic. The engineer and Working Roads Supervisor support the following:
  - Add to the shoulders of the road;
  - Paint a solid centre yellow line;
  - Install 'keep right' signage;
  - o Possibly implement the area as a 'Community Safety Zone'.
- The Township will be addressing these concerns with MTO;
- Some funding has been allocated within the 2023 Municipal Budget to address safety concerns along Scotia Road.
