

THE CORPORATION OF THE TOWNSHIP OF PERRY

BY-LAW No. 2026-46

Being a By-law to Establish Speed Limits
within the Township of Perry

WHEREAS Section 27 (1) and 28(1) of the *Municipal Act, 2001, S.O. 2001, c. 25* as amended, authorizes municipalities to pass by-laws in respect to highways within its jurisdiction or joint jurisdiction;

AND WHEREAS Subsection 128 (2) of the *Highway Traffic Act, R.S.O. 1990, c. H.8*, as amended, authorizes the council of a municipality to prescribe by by-law a rate of speed for motor vehicles driven on a highway, or portion of a highway, under its jurisdiction;

AND WHEREAS the Council of the Township of Perry deems it desirable to set a rate of speed for Township highways within the Settlement Areas of Novar and Emsdale, as well as on certain Township highways located outside of those Settlement Areas, for the health and safety of its residents;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF PERRY ENACTS AS FOLLOWS:

1. DEFINITIONS:

"*Highway*" means a common and public highway and includes any bridge, trestle, viaduct or other structure forming part of the highway and, except as others provided, includes a portion of a highway; as defined in the *Municipal Act S.O. 2001, c. 25, s. 1 (1)*, as amended.

2. RATE OF SPEED:

2.1. The rate of speed on Township highways, within the Settlement Areas of Novar and Emsdale shall be 40 kilometres per hour, unless otherwise posted, as detailed in Schedule 'A' attached hereto.

2.2. The rate of speed on all Township highways, outside of the Settlement Areas of Novar and Emsdale, shall be 60 kilometres per hour, unless otherwise posted, as detailed in Schedule 'B' attached hereto.

3. PENALTY:


The penalties provided in Subsection 128 (14) of the *Highway Traffic Act, R.S.O. 1990, c. H.8*, shall apply to offences against this By-law.

4. The Working Roads Supervisor, or their designate, shall be and is hereby authorized, directed and empowered to obtain, install and maintain all such signs as may be necessary to implement this By-law.


5. By-law 2022-105 is hereby repealed.
